The Southwestern Idaho Electrical JATC will accept applications for apprenticeship at the Southwestern Idaho Electrical JATC, 121 East 34th Street, Boise ID from 8:00 am until 4:30 pm Monday through Thursday and 8:00 am until 4:00 pm on Friday. You must apply in person and submit a ~~NON REFUNDABLE~~ application fee in the amount of \$25.00 in the form of Check, Money Order Debit or Credit Card **ONLY – CASH WILL NOT BE ACCEPTED**. To meet the minimum qualifications for apprenticeship, the applicant must:

1. Be a minimum of 17 year of age
2. Be at least a high school graduate, or have a GED or a two year Associate Degree or higher
3. Show evident of successful completion of: one full year of high school algebra with passing grades or one post high school algebra course with a passing grade.
4. Provide an **office transcript** for high school and post high school education and training. All GED records must be submitted if applicable. (Documentation of the above is required by official transcripts showing courses and grades from high school or college. Proof of diploma or GED must be presented in English. Non-English diplomas and/or transcripts must be translated and notarized with notary seal.
5. Show a valid driver's license
6. Submit a DD-214 to verify military training and/or experience if they are a veteran and wish to receive consideration for such training/experience.
7. Qualify for an interview using the electrical trade's aptitude test developed and validated by the American Institutes for Research.
8. Prior to being indentured, applicants selected from the pool of interviewed applicants will be required to provide results of a negative drug test.
9. Individuals who can verify (proper documentation required) that they have worked a minimum of four thousand (4000) hours specifically in the electrical construction trade; do not need to meet the requirements of items 2 and 3.

The recruitment, selection, employment and training of apprentices during their apprenticeship, shall be without discrimination because of race, color, religion, national origin, sex or age except the applicants must be at least 17 years of age to apply and 18 years of age at time of indenture. The JATC does not, and will not, discriminate against a qualified individual with a disability because of the disability of such individual. The sponsor will take affirmative action to provide equal opportunity in apprenticeship and will operate the apprenticeship program as required under applicable law and lawful regulations issued thereunder.

Applicants who meet all basic requirements will be interviewed by the JATC. Apprentices will be selected in order of their final ranking.
