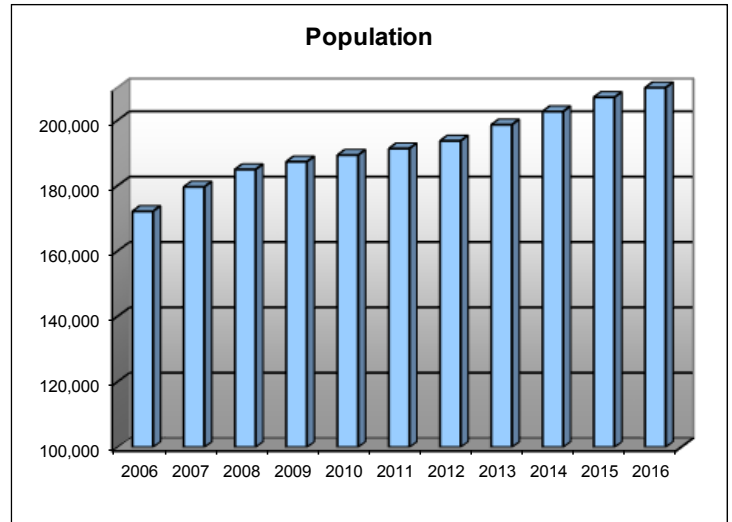

Workforce Trends

Population

Canyon County is Idaho's second most populous county with 211,698 residents. It is the seventh smallest county geographically. It lies within the Boise metro area and combined with Ada County, Idaho's largest county, the population is almost 656,000. Many people are drawn to Canyon County by lower housing prices and a rural life style within commuting distance of jobs in Ada County. The population grew 39,510, or 23 percent, from 2006 to 2016. Growth remained robust over the past year at 2.2 percent after posting 2.6 percent in 2013 and 2 percent in 2014.

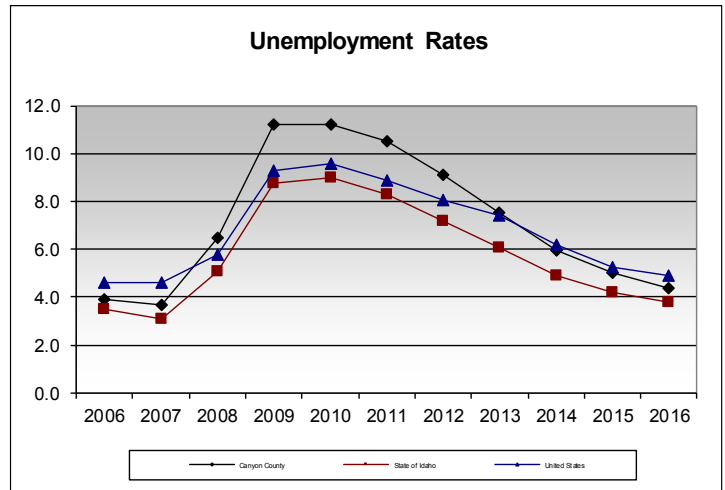
The county's largest cities, Nampa and Caldwell, rank 3rd and 6th, respectively, statewide. Nampa's population was 91,382, a 1.8 percent increase from 2015 and Caldwell had a 3.1 percent increase to 53,149. Middleton with a population of 7,168 ranked 5th in percentage growth at 5.4 percent.



Labor Force & Employment

The Canyon County civilian labor force exhibited strong growth throughout the past decade, increasing by 11,189, or 14 percent since 2006. By 2005, the county had started reaping the benefits of the housing boom and accompanying commercial construction. That drove the unemployment rate to record lows in 2007 before the recession dealt a blow to the county in the second half of 2008. The housing bubble, which fueled the expansion, had burst. The unemployment rate added 2.8 points from 2007 to 2008, then shot up to 11.3 percent in 2009 and remained there through 2010. 2011 saw the first unemployment rate decline since the recession, dropping to 10.6 percent. The county has since continued to recover, with the rate dropping to 4.4 percent in 2016.

As part of the Canyon County's robust recovery, the county's covered employment reported nearly 2,600 additional jobs, a 4.4 percent increase from 2015. Total covered employment in 2016 was 61,131, a record level. Every major industry group showed an increase in the number of jobs. The leaders



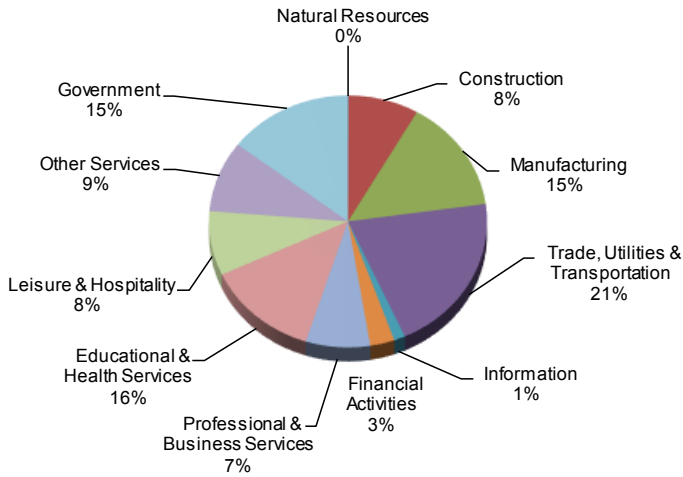
were manufacturing, which added 575 jobs, and leisure and hospitality, which added 516 jobs.

Over the decade the job growth was 11.1 percent, an additional 6,099 jobs. However there were four industries that have not fared a well—mining, construction, manufacturing and financial activities. Although each have reported gains in the past year, they continue to struggle in recovery efforts. Construction jobs remain 25 percent below the 2006, pre-recession, levels. Trade, utilities and transportation has added more than 1,800 jobs. Education and health services; leisure and hospitality; and government each added more than 1,600 jobs.

Per Capita Income and Wages

Despite commuters who work in neighboring Ada County, Canyon County per capita income ranked 42nd out of the 44 counties in 2016. The recent data showed some improvement, up \$706 to \$29,305, which put the county at 74 percent of state per capita income and 60 percent of national per capita income.

Average covered wages in 2016 increased 2.5 percent to \$34,751. The wages range from \$14,136 in the leisure and hospitality sector to over \$43,000 in financial activities and manufacturing. Although leisure and hospitality has the lowest wages, it experienced the largest percent increase, 4.7 percent. Only information experienced a decrease, 0.3 percent,
