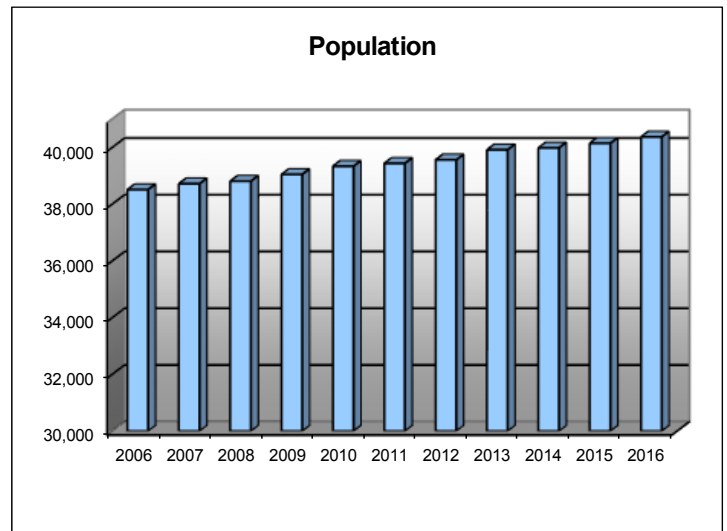
Workforce Trends

Population

Nez Perce County's population grew 5 percent from 38,513 in 2006 to 40,369 in 2016 while the U.S. population grew 8 percent and Idaho's population grew 13 percent. Slow job growth reduced migration into the county while an aging population reduced the birth rate.

Nez Perce is closely tied to Asotin County, Washington. Many Asotin County residents work in Lewiston. Asotin County grew 4 percent from 21,133 in 2006 to 22,306 in 2016.

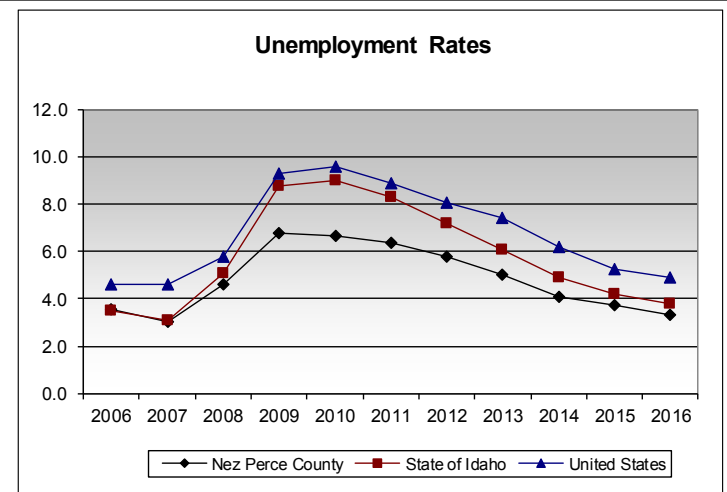
The Nez Perce County seat, Lewiston, had a 2016 population of 32,872. The population in Lapwai was 1,148, in Culdesac 376, and in Peck 198. Clarkston's population was 7,341.



Labor Force & Employment

Nez Perce County is a regional hub for retail, health care, media, government and transportation. Lewiston has the largest airports in north central Idaho. It also is Idaho's only seaport. Barges regularly travel the Snake and Columbia rivers from Lewiston to the ocean. Asotin, Clearwater, Columbia, Idaho and Lewis counties rely on the Lewiston area for goods and services unavailable locally. In addition, many residents of neighboring counties work in the Lewiston area.

Lewiston is home to Lewis-Clark State College, a four-year school also offering professional-technical training programs. Its enrollment hovers around 4,600. Nez Perce County's largest employer is Clearwater Paper Inc., whose 1,400 employees make tissue and paperboard. The Vista Outdoors bullet plants in Lewiston employ over 1,200 people. St. Joseph's Regional Medical Center, the heart of Lewiston's



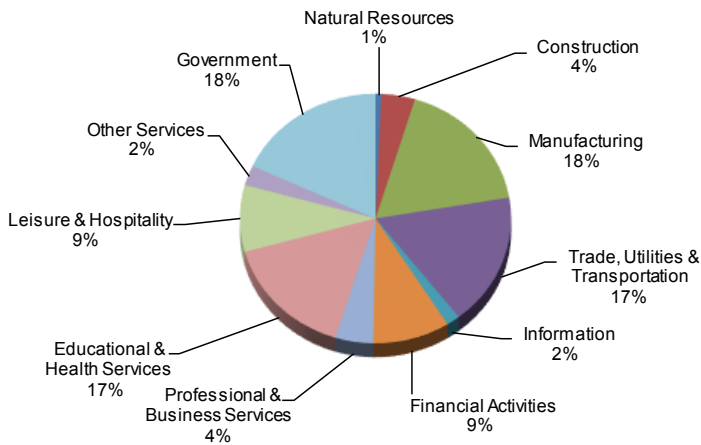
bustling medical community, employs about 1,000 while the Cambria Health (Regence BlueShield) center in Lewiston employs 450 and Lewis-Clark State College employs over 700. The Nez Perce Tribe employs 500 at its Lapwai headquarters and another 250 at its casino resort near Lewiston.

The county has experienced exceptional growth in manufacturing. Big boosts in the last five years include openings of the Schweitzer Engineering Laboratories plant, now employing 400, and the Howell Munition's ammunition plant, employing more than 300.
