



Governor Otter’s Hire One Tax Credit is designed to jump-start Idaho’s economy by rewarding employers who create new jobs. Learn more at hireone.idaho.gov.

The Idaho Hire One Tax Credit is a sliding-scale income tax credit for employers when they pay \$12 to \$15 an hour or more plus benefits depending on qualifying criteria, such as an employer’s unemployment insurance tax rating and the average unemployment rate during the prior year for the county where the job was created and the work performed.

This program ties in with the Hire One Vet initiative introduced in April by the Idaho Chapter of Employer Support of the Guard and Reserve organization.
